Main activities include administering the museum, maintaining three historical buildings, and conducting educational activities.

Museum Operations: The Association owns and manages the Steilacoom Historical Museum and three historical buildings. The facilities are staffed by volunteers and docents. Donations are accepted at each facility. The museum is also used as a classroom and office for the Association. The cost of utilities, repairs, etc., are consolidated so expenses are estimates. The museum store/gift shop sells logo clothes, books on the history of the area, replicas of historic toys, and other historical items. It made \$8,496 in 2024.

4b (Code:) (Expenses \$ 0 including grants of \$ 0) (Revenue \$ 0)
Education: SHMA docents and volunteers set up exhibits and informational materials in the Museum and the historic buildings. The Curator accessions and maintains historic papers and artifacts which are available for research and are periodically put on display. Presentations on various topics are given by historians. Other activities are arranged with 4th grade teachers as part of their curriculum and a separate Kids Club is conducted for grade schoolers.

4c (Code:) (Expenses \$ 0 including grants of \$ 0) (Revenue \$ 0)
Historical Collections: The Association maintains collections of pioneer clothing, tools, furniture, photographs, store records, etc. that represent life in the Steilacoom area over the last 175 years. These items are either on display or kept in a locked climate-controlled area of the historic Orr Home. Many of the items were donated to the Association. Some of particular importance to the community are purchased when they are put up for sale. The end result is a vast and varying source of historic examples that are seen by visitors, especially school students, and made available to researchers, in accordance with the Association's mission.

Schedule D, Part III, Line 1 - The Association periodically receives or, in special cases, purchases historic artifacts such as carpentry tools and letters. These are safeguarded in a locked area and put on display, usually on a rotating basis. They are also available for research purposes.

Schedule D, Part III, Line 4 - Items in the Association's collections include pioneer clothing, tools, furniture, photographs, store records, etc. that represent life in the Steilacoom area over the last 175 years. These items are either on display or kept in a locked climate-controlled area of the historic Orr Home. Many of the items not on permanent display may be placed on temporary exhibits in the Museum or one of the Association's three historic buildings. Many of the items were donated to the Association. Some of particular importance to the community are purchased when they are put up for sale. The end result is a vast and varying source of historic examples that are seen by visitors, especially school students, and made available to researchers, in accordance with the Association's mission.

Schedule D, Part V, Line 4 - The Association's quasi-endowment consists of gifts from donors and earnings from investments. The Board adopted policies in 2013, updated in 2018, for management and use of the funds. The objectives are to (1) raise at least \$500,000 before withdrawing earnings to cover certain operating expenses and/or (2) be used in case of a financial emergency. In the latter case, it would take a vote by the Board of Trustees to withdraw from the endowment fund.

Form 990, Part VI, Section A, Line 6 - The Association has approximately 400 members. There are various categories of membership including individual, family, senior individual, senior family, and lifetime. The last was implemented in the 1980s when there was a need for funds. There have been no new life memberships offered since then. There is no Association stock and no stockholders. All members receive the newsletters, e-blasts, and other sources of information.

Form 990, Part VI, Section A, Line 7a - All members can vote for the President, Vice President and Trustees at the Association's Annual Meeting in December. All positions are at-large. There are no districts or special interests represented.

Form 990, Part VI, Section B, Line 11b - The 990 is prepared by and reviewed by the independent auditor and the Chief Financial Officer. Copies are posted on our website, www.SteilacoomHistorical.org, and made available to anyone who requests one.

Form 990, Part VI, Section B, Line 12c - All contracts and projects are reviewed by the Board as a whole. Any potential conflict(s) or interest is/are discussed at that level. The Association's Finance Committee, Chief Financial Officer, and Treasurer review every expense to ensure no potential conflicts of interest exist. Further, a Conflict of Interest Certification must be signed by each Trustee and Officer in January of each year.

Form 990, Part VI, Section B, Line 15 - With one exception, all officers are volunteers and are not paid. The exception is the Curator, who is our only employee. Her starting hourly rate was based on similar work done by other museum associations in the area. Each year the contract and the hourly rate are approved by a vote of the Board of Trustees and documented in a written contract and in the minutes of the Board meeting.

Form 990, Part VI, Section C, Line 19 - The Associations By-Laws, Policies, and Form 990 are posted on our website, www.steilacoomhistorical.org, and made available to the public upon request.
